6. The decision of the competent authority regarding selection of candidates shall be final and no representation will be entertained in this regard.
7. In case any declaration by the candidate is found to be false or if the candidate has wilfully suppressed any material/information relevant to his/her appointment, his/her selection shall be cancelled ab-intio and action as Warranted under rules shall be initiated against the erring candidates.
