 - d. My appointment will get terminated automatically and I shall have no claim on the post as soon as the post is filled by the competent authority on permanent basis.
 - e. If the documents filed by me are found wrong / incorrect at any point of time, my appointment shall be terminated immediately and disciplinary action and legal proceedings shall be initiated against me.
