Pursuant to the recommendations of selection committee which met on 20th June 2019, the following PSC confirmed doctors who had applied for the tenure post of Senior Residents/Registrars/Demonstrators in the department shown against each at Govt. Medical College Baramulla are provisionally selected as Senior Residents/Registrars/Demonstrators Subject to the condition that proper No Objection Certificate from Directorate of Health Services Kashmir/Jammu shall be issued in their favor, initially for a period of one year which can be extended on the basis of good performance and conduct upto a maximum of 3 yrs for MD, 2 yrs for diploma holders:

However engagement of the selected doctors shall be subject to the following conditions:

- That the doctors shall submit their Joining report in the office of the Principal Government Medical College Baramulla within a period of 15 days from the date of issuance of this order.
- The appointment of the above doctors is further subject to submission of an affidavit duly attested by the Judicial Magistrate/First Class Magistrate to the effect that :
- He/ she will not participate in any kind of strike during the period of his /her tenure engagement.
- In the event he/she proceeds on Strike, his /her tenure engagement shall be terminated without any notice as the service is covered under ESMA Act.
- He/ She shall remain disciplined during the tenure period; any kind of misconduct shall make him/ her liable for termination without any prior notice.
- He/ She is not involved in any Criminal Activity or there is no FIR pending or registered in any criminal department or police station against him / her.
- He/ She will not indulge in private practice during the tenure. In case he/she is found doing private practice his/ her appointment shall be terminated without any Notice.
