4. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
5. Relevant category certificate, where applicable.
6. Any other documents as required under rules.

The appointment of the candidate shall be subject to the following conditions:-

- a. The appointees shall report to the Principal, Govt. Medical College, Baramulla for joining within a period of 21 days from the date of publication of this order, failing which they shall forego their right to appointment which shall be deemed to have been cancelled ab initio without any further notice.
- b. Each appointee shall give an undertaking in the shape of an affidavit duly signed by 1st class Magistrate to the effect that:-
 - I). He /She has not been appointed in any other Govt./Semi-Govt. department and is not working there at present
 - II). In case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID), J & K, the candidate shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.

- c. Verification/ genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities
- d. Salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (b) and (c) above are received in their favour.
- e. The appointment of these candidates shall be governed by S.O-194 OF 2020 dated: 17-06-2020.
- f. The appointees shall be governed by the “New Pension Scheme” as notified Vide SRO-400 of 2009 dated 24-12-2009.
- g. The interim arrangement, if any, made against the above posts shall be deemed to have been terminated forthwith.
- h. The appointment in Divisional cadre is not transferable from one division to another or from one Medical College to another
- i. The appointment of the selected candidates shall further be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
- j. The inter-seniority of the above appointees shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J & K services selection Board.
- k. The selected candidates so appointed shall not be allowed to resign from the post from Government Medical College Baramulla during the probation period.
