**The appointment of these candidates shall be subject to the following conditions:-**

- a. The appointees shall report to the Principal, Govt. Medical College, Baramulla for Joining within a period of 21 days from the date of publication of this order,



- failing which they shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
- b. Each appointee shall give an undertaking in the shape of an affidavit duly signed by 1<sup>st</sup> class Magistrate to the effect that:-
- I). He /She has not been appointed in any other Govt./Semi-Govt. department and is not working there at present
- II). In case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID), J & K, the candidate shall have no right to claim his/her appointment and his/her appointment as such , shall be deemed to have been cancelled ab-initio.
- c. Verification/ genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities
- d. Salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (b) and (c) above are received in their favour.
- e. The appointment of these candidates shall be governed by S.O-194 OF 2020 dated: 17-06-2020.
- f. The appointees shall be governed by the “New Pension Scheme” as notified Vide SRO-400 of 2009 dated 24-12-2009.
- g. The interim arrangement, if any, made against the above posts shall be deemed to have been terminated forthwith.
- h. The appointment in Divisional cadre is not transferable from one division to another or from one Medical College to another
- i. The appointment of the selected candidates shall further be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
